- **Genre** : All genres are accepted (Excluding cheerleading, button, or any acrobat)
- **Teams** : 20 (Japan and outside Japan)
- **Performance Time** : 2 to 3 minutes per team.
- **Entry Fee** : (Outside Japan) \$150 per team
- **Reward** : One free 'Lanikai Juice' ticket for all participants. Valid at 'WaikiKitchen ~Taste of Local~', a co-hosting local food festival.
- **Prize** : Elect Grand Prize and 2nd Grand Prize. Two teams will perform at Honolulu Festival Grand Parade in Kalakaua Ave, Sunday, March 8.

■ Judging procedures and points

● Each judge holds 50 points

- Technique/Skill 10 points
- Impression/Impact 10 points
- Composing/Staging 10 points
- Cooperativeness/ Synchronization 10 points
- Choreograph 10 points

● Any dance genres are accepted

Judges will focus on dancers who can perform and entertain. (Excluding button, cheerleading, or any dangerous acrobats)

● No acrobat with run up is allowed for cheerleading and dance performance.

● Audio source must be submitted by CD. (Playable with CD player)

● Participating teams can join rehearsals on the event day and the prior day.
